7.0 COMMUNICATIONS

7.1 Superintendent Update

Superintendent Bissonette shared with the Board the class size report. The class size report is produced twice a year by Data Specialist, Shellie Scobee. The report summarizes the policy and then gives the class sizes at each school and those classes that have above recommended ratios. The average class size at Elizabeth High School is 15 students per class, the average core class size is 19 students per class, and the student/teacher ratio for the entire school is 20:1. There are no classes at the high school that exceed the student/teacher ratio of 30:1. The Elizabeth Middle School average class size is 23 students per class and the student/teacher ratio is 28:1. There are three classes at the middle school that exceed the student/teacher ratio. Those classes are 8th grade WEB, 6th grade Geography and 6th grade Reading. The average class size at Singing Hills Elementary is 19 students per class and the student/teacher ratio is 16:1. The ratios in elementary school vary by grade level and no grade level at Singing Hills exceed the student/teacher ratio. The average class size at Running Creek Elementary is 19 students per class and the student/teacher ratio is 15:1. Again, the ratios in elementary school vary by grade level and no grade level at Running Creek exceed the student/teacher ratio. The class size report gives a further break down and also the number of online students assigned to each class. Superintendent Bissonette also discussed lower class sizes and minimizing risks of COVID-19 in schools.

Bissonette followed up on the question from the last Board meeting regarding projected enrollment numbers. Looking at patterns and trends of students that have left and joined the district, the change appears to be fewer students joining the district than in the past and not necessarily students leaving. The district is still looking at the data and trying to interpret the reasoning.
