A Work Session Board Meeting of the Elizabeth School District was held on Monday, August 24, 2020, in the Board Room, District Office.

6.1Terry Wilson Retirement Recognition

The Board of Education recognized Director of Transportation, Terry Wilson, for his upcoming retirement. Terry has been with the district for 33 years and will be greatly missed.

7.0 COMMUNICATIONS

7.1 Superintendent Update

Elizabeth High School Counselor, Casey Waters joined the Board meeting via Zoom to share with the Board an update on the alternative program that is being offered at the high school for 19 students. Approximately 4 students from Frontier transferred to the high school and after a review of student records, 15 other students were found that could benefit from alternative learning. Teacher Adam Payton is the main teacher for the program and is covering many courses for the social studies credits and Teacher Lori Horton is covering the literature courses. Cardinal Recovery is being utilized for mostly math and science but many other courses are available to the students. The classes include a more project-based learning in a smaller environment.

In terms of the 100% Online option, there is currently a total of 91students at Elizabeth High School, 51 at Elizabeth Middle School, 40 at Running Creek Elementary, and 28 at Singing Hills Elementary, for a total of 210 students, which is just over 10%. CDLS, which is our 100% online program, has an enrollment deadline that is mid-September. The district has said that students who enroll in the online program and have a change of heart can return to our classrooms for up to two weeks into the school year. After that, they will need to stay online until the next grading period for that school. Discussion was had about the online program and the cost for the district. There are currently 16 students that were enrolled in our district last year that have turned in their notice of intent to homeschool this year.

The district is moving forward with the Homegrown Talent Initiative and is looking at hiring a project manager. Bissonette shared the graduate profile graphic that holds all of the traits expected of a graduate. Those traits include; leader, empathetic and collaborative, adaptable and resilient, effective communicator, independent learner, academically prepared, and entrepreneurial. The graphic will be used to showcase the expectations of Elizabeth High School graduates.

Superintendent Bissonette spoke about the return to school having gone smoothly. Students and staff were very cooperative with wearing their masks and all guidelines set forth were being followed. One unresolved concern is an art class at the high school that has a large number of students. It is a highly desired certificate class and the school is working on improvements to the classroom. The district is following CDPHE guidelines. The district will work with public health if there are any COVID cases to decide who is quarantined. The focus of the district is on how to mitigate the spread of the virus in schools. Discussion was had about staff returning and how many staff members have chosen not to return. Discussion was also had about the health form that is required for parents to fill out. The district chose this one time approach as opposed to a daily form parents would be required to fill out. If there is a positive COVID test for someone within the school, the results go into a state database. The county looks at the database and will contact the individuals and have a discussion about close contacts with other individuals. The county health department then makes recommendations to the individuals.



Bissonette discussed with the Board the final topic of the student data management software Alpine. Teachers have been using this software to keep student achievement data in the district system. Alpine was purchased last year by a company which has very little transparency. There is a concern about this ownership change and our district is hesitant to renew it. The district plans to make a decision about this software sometime around the end of the month.
