RECOMMENDATION:

Approve motion as presented.

BACKGROUND AND FINDINGS:

Pursuant to CRS 39-5-128(1), the Board of Directors for the Elizabeth School District, must certify the mill levies for the various tax-supported funds of the District by December 15. The County Assessor's office must provide the assessed values within the school district by December 10th. The Elbert County Assessor's office has calculated the assessed values of the property located within the boundaries of the Elizabeth School District and submitted that data to the District. Based on the information submitted to the District's finance department, the proper mill that should be remitted to the Elbert County Board of County Commissioners is 26.788 mills for the Elizabeth SD General Fund and 6.479 mills for the Elizabeth SD 2018 MLO for a combined total of 33.267 mills.

County Assessor Susan Murphy approved listing the two mills separately on the tax bill to help taxpayers better understand their school taxes. The General Fund mill levy is set by the state and is referred to by the Colorado Department of Education as Total Program funding. The 2018 MLO levy is derived from the successful 2018 ballot question authorizing the collection of \$1.59M in local taxes for the specific uses described in the ballot question.

FISCAL IMPACT:

Approving this motion will allow Elbert County to properly collect the various property tax-supported funds of the District.

Superintendent's Review:

Recommended Motion: I move to certify the 2020 mill levy for Elizabeth School District's General Fund in the amount of 26.788 mills for the Elizabeth SD General Fund and 6.479 mills for the Elizabeth SD 2018 MLO for a total of 33.267 mills and authorize the Superintendent and Director of Finance to alter the mill levy if the assessed valuation changes.
