7.1 EHS Student Allie Lindsey-CASB GT Presentation in December

Elizabeth High School students Allie Lindsey and Peter Johnson presented on behalf of the Colorado Gifted and Talented Student Board. The Colorado Gifted and Talented Student Board (CGTSB) is made up of students from the following high schools, Elizabeth, Cherry Creek, East High, Fort Collins and Castle View. The Board's mission is to obtain student input from gifted students in Colorado to enhance the GT experience through the advancement and unification of K-12 education around the state. The student board aims to provide equal opportunity to all GT students regardless of background and geographical location.

Peter and Allie requested that the Board be present at their presentation during the Colorado Association of School Boards (CASB) convention. The presentation will be on Friday, December 6th from 2-3 pm at the Broadmoor Hotel in Colorado Springs. The students from CGTSB will present on the following topics; support of geographical differences, making advanced learning plans more meaningful for students, the start of an academy that would allow students to work on a passion project within their community along with increased access to identifying gifted and talented students and teacher training.

7.2 Superintendent Update

Superintendent Bissonette shared the class size report. The only concern currently is the number of middle school classes that are either at or above the recommended numbers. The only solution is additional teachers but that is cost prohibitive, given overall enrollment numbers for the school. Class sizes for the rest of the district are fairly low.

The County Assessors Office has agreed to approve a change in the language of the tax bill for Elizabeth School District. The tax bill will have two line items. The total program mill levy which is set by the state and the locally approved override bill. This will allow tax payers to be able to monitor the mill and the amount they are paying for the tax they voted on. Bissonette asked the Board to weigh in on what the line items on the tax bill could say. Discussion was had on options and consensus was achieved on the two line items:
